AS A COMMUNITY FOCUSED EVENT, HUDSON RECREATION WILL CONTINUE ITS LONG-STANDING TRADITION OF PRIORITIZING THE PARTICIPATION OF HUDSON BASED NON-PROFITS AT THE EVENT, FREE OF CHARGE. LIMITED ADDITIONAL VENDOR SPACES MAY BE AVAILABLE FOR ALL OTHERS (FEE APPLIES). ALL ARE WELCOME TO APPLY TO PARTICIPATE IN OUR EVENT. PREFERENCE WILL BE GIVEN TO LAST YEAR'S VENDORS AND HUDSON BASED NON-PROFITS PRIOR TO NEW VENDORS BEING CONSIDERED, WITH PRIORITY GIVEN TO HUDSON BASED VENDORS.

#### **VENDOR REQUIREMENTS:**

- VENDORS WILL BE RESPONSIBLE FOR TRANSPORTING ALL NECESSARY ITEMS TO AND FROM THEIR ASSIGNED LOCATION(S). HUDSON RECREATION WILL NOT HAVE STAFF AVAILABLE TO ASSIST.
- ALL VENDORS WILL BE ASSIGNED A 10'X10' SPACE.
- NO VEHICLES WILL BE ALLOWED ON EVENT GROUNDS, UNLESS PREVIOUSLY AUTHORIZED BY HUDSON RECREATION.
- THIS IS INTENDED TO BE A FAMILY-FRIENDLY EVENT. WE EXPECT ALL VENDORS TO ACT ACCORDINGLY AND REFRAIN FROM ANY ACTIONS AND/OR CONVERSATIONS THAT DEVIATE FROM THE EVENTS INTENDED PURPOSE.
- NON-PROFITS MUST DIRECTLY IMPACT HUDSON AND MUST HOST AN ACTIVITY FITTING TO RECFEST (SEE LIST OF PAST & SUGGESTED ACTIVITIES FOR IDEAS).
- VENDORS MUST SUPPLY THEIR OWN TENT, TABLES, CHAIRS & DISPLAYS. NO ELECTRICITY
  AVAILABLE. TENT SET UP IS ON GRASS. NO STAKES WILL BE ALLOWED, SO PLEASE BRING
  TENT WEIGHTS. TENTS NOT ADEQUATELY SECURED VIA TENT WEIGHTS WILL NOT BE
  ALLOWED.
- ORIGINAL CRAFT WORK ONLY. (NO IMPORTS OR PURCHASED ITEMS INTENDED FOR RESALE.) NO DISCOUNT TABLES (YARD SALE/FLEA MARKET TYPE).
- ITEMS SOLD OR ACTIVITY HOSTED MUST FIT A FALL THEME. ANY VENDORS THAT DO NOT MEET THE NEEDS OF OUR EVENT WILL NOT BE ACCEPTED.
- CRAFTERS MUST PROVIDE PHOTOS OF ITEMS AND SET UP TO BE SUBMITTED WITH THIS
  APPLICATION.
- NO SALE OF WEAPONS OR FIREARMS, AS WELL AS ANY ITEM PROHIBITED BY LAW.
- VENDORS MAY HAVE A DESIGNATED PARKING AREA (TBD); LIMIT 1 CAR PER VENDOR PLEASE.
